# Christian A. Herb

#### **President**

Connecticut Energy Marketers Association

Chris Herb has been with the Connecticut Energy Marketers Association (CEMA) for 22 years, where he held the position of vice president for 12 years and currently serves as president. In this role, he is principally responsible for state government relations work and staying out of the way of the staff, who ensure that members are adequately served in the areas of management education, technology, networking, information sharing, taxes, transportation, occupational safety and health administration, and all the environmental, regulatory, and legal issues that accompany these areas. Chris is also the incoming chairman of the Energy Marketers of America State Executives Conference and has served on the State of Connecticut Low Income Energy Advisory Board for the last 15 years.

In addition to his responsibilities with CEMA, Chris also runs ENTECH, a state-certified not-for-profit trade school geared to preparing people for the state licensing exam, their apprenticeship, and ultimately a career in the HVAC trade. ENTECH provides students a pathway to become CDL drivers and also offers a number of certification programs, including CETP, OSHA 30, and EPA, along with vibrant continuing education programs.

Chris worked for Bob Dole in his campaign for president of the United States from 1995 to 1996 as a congressional district coordinator. From 1999 to 2003, he was elected and served for two terms as a burgess for the Borough of Naugatuck, where he was the liaison to a number of town departments and chaired numerous subcommittees. Prior to serving as an elected official in his hometown of Naugatuck, Chris worked as a legislative aide at the Connecticut General Assembly from 1996 to 2000. As an aide, he worked as the liaison to dozens of state agencies, managed constituent relations, testified before legislative committees, and performed research on legislative issues. He also worked as the director of public support for the American Red Cross in the late 1990s. Prior to his time with the Red Cross, he was the head track and field coach and an assistant football coach at Naugatuck High School.

Chris remains an active part of his community, where he has taught Sunday school at the Naugatuck United Methodist Church for nearly 12 years and also runs a number of church fundraisers like the Pumpkin Patch and dinners. He also served as a commissioner on the Charter Revision Commission and helps out on the weekends as a volunteer track and field coach.

Above all, he is the VERY PROUD father of two boys, Austin and Steven, who are both in college. Chris lives with his immensely patient, understanding, and forgiving wife, Lisa, who is a school teacher in Naugatuck and will be completing her Ph.D. this fall.

Chris has informed his wife that if he is required to call her doctor, he will request that the CEMA Board of Directors change his title from president to emperor because he is fairly certain that an emperor is higher up than a doctor.



# Rocco J. Lacertosa

#### **Chief Executive Officer**

New York State Energy Coalition

New York City represents the single largest residential heating oil market in the entire country. It's also the home of one of the nation's first Bioheat® fuel requirements, a 2% minimum blend that was later increased to 5% and later expanded to include neighboring Long Island and Westchester County – collectively known as the New York City metro area or simply downstate New York.

Rocco Lacertosa has been representing this market's interests before local, state and federal policymakers as an association leader since 2015. Formerly the chief executive officer of the New York Oil Heating Association, he directed that group's merger with the Oil Heat Institute of Long Island to form the New York State Energy Coalition (NYSEC) in 2020 and has since served as CEO of NYSEC.

Prior to this, Rocco held several senior level leadership positions on the retail side of the industry. He is perhaps the only NEFI Legend being awarded tonight who can say that he remembers what it was like to drive a delivery truck during the oil embargoes of the 1970s. As such, he is well versed in many of the issues our industry currently faces. He has been working in the heating fuel trade since 1966 and has experienced firsthand the many changes this industry has undergone since then.

A realist, Rocco believes in an "all of the above" approach to energy policy. At the same time, he is not a climate change denier. He looks out the front door of his home in New York each morning and can feel that there is something clearly going wrong in our atmosphere. Facing this reality, Rocco helps to lead our industry toward a cleaner fuel that will assist local communities, New York State and the federal government in achieving their climate goals.



# Charles E. Summers, Jr.

#### **President & CEO**

Maine Energy Marketers Association

Even with just over two years of experience in the energy sector, even in a room full of industry Legends, Maine Energy Marketers Association (MEMA) President & CEO Charlie Summers is by far the most decorated of tonight's honorees.

Charlie came to MEMA in 2020 after serving as the Principal Deputy Assistant to the U.S. Secretary of Defense. Prior to that, he served the state of Maine as Secretary of State and as a State Senator. Additionally, he has served in the U.S. Navy Reserve since 1996 as a public affairs officer, currently holding the rank of Captain. He is also Commanding Officer of Naval Reserve Naval Information for the U.S. Naval Forces Europe-Africa/U.S. 6th Fleet.

Today, Charlie serves our industry with the same dedication he has always demonstrated.

An Iraq War Veteran, Charlie has shined light on MEMA's patriotism and along with it, the camaraderie that exists both within the membership and among the students and instructors at the MEMA Technical Education Center (MTEC). His unique experiences in the military have given him a keen eye to see areas that require improvement and immediate attention. It is this sensibility that will keep MEMA thriving and relevant as we approach the end of 2022.

As for his decorations, Charlie has been awarded the Defense Meritorious Service Medal, Meritorious Service Medal, Joint Service Commendation Medal, Navy and Marine Corps Achievement Medal (four awards), U.S. Army Combat Action Badge, Afghanistan Campaign Medal, Iraq Campaign Medal and various other service awards.

We thank him for his service to both our country and our industry, and we are proud to honor him with the 2022 NEFI Legends Award.

# Michael Ferrante

#### **President**

Massachusetts Energy Marketers Association

Born and raised in the neighborhoods of Boston, Michael Ferrante received his undergraduate degree from Salem State University and his master's degree in broadcast journalism from Boston University's School of Public Communication. Following his graduate work, he began his professional career as a television news writer and broadcast news producer with WCVB-TV, Channel 5, the ABC News affiliate in Boston.

Michael then served as the local media spokesman for Wang Laboratories, which at the time was a Fortune 50 company and recognized worldwide as a pioneering high-tech firm. From there, he was recruited by Missouri-based Monsanto Company to work as director of public affairs, assisting in communicating the environmental cleanup and eventual closing of one of the oldest chemical manufacturing facilities in the country located in Everett, Massachusetts. The site is now occupied by the Encore casino. While working for Monsanto, Michael collaborated with trade associations on emerging state and federal regulations governing chemicals and petroleum. One of those associations was the Better Home Heat Council of Massachusetts – now known as the Massachusetts Energy Marketers Association (MEMA).

Michael's transition to the association occurred during staff changes at both the number one and number two leadership positions at the Better Home Heat Council. Ed Scott, with Scott Energy, who served as chairman of the Council at the time, led the search team that hired Michael. Before assuming his current role, Michael worked under another Legend, Jack Sullivan.

Michael's achievements have had a significant positive impact on the industry. Using his media relations skills over the years, he has been a spokesman on many important topics, including energy pricing, petroleum supply, natural gas competition, electrification, climate legislation and policy, and renewable biodiesel/Bioheat® fuel. Michael's commitment to advancing Bioheat fuel for the industry spans 20 years of work with his friend and colleague Paul Nazzaro and the National Biodiesel Board (NBB), now the Clean Fuels Alliance of America. Because of his work, NBB named Michael a Biodiesel Ambassador and he has been a featured speaker at several biodiesel conferences.

Michael has also held leadership roles with the heating fuel industry's marketing and advertising groups, including the Metropolitan Energy Council, East Coast Energy Council, the American Energy Coalition and the Consumer Education Committee for NORA, the National Oilheat Research Alliance.

In the area of government affairs, Michael helped represent Massachusetts before the U.S. Congress as the industry collectively lobbied for passage of the statute establishing NORA 22 years ago. In Massachusetts, Michael was the industry's advocate and lobbyist as the state passed landmark legislation in 2008, including the Global Warming Solutions Act, the Clean Energy Biofuels Act, and the Green Communities Act. His work on those laws earned him an appointment on the state's Energy Efficiency Advisory Council, a position he still holds today. The Council oversees the development of Mass Save programs and heating equipment rebates.

Over the past six years, Michael's government affairs accomplishments for the industry in Massachusetts have been noteworthy. He played an integral role in the establishment of regulations for the Alternative Energy Portfolio Standard, the first program of its kind in the U.S. that provides financial incentives for retailers selling renewable biofuel blends in heating oil. He managed to turn back two attempts by the Town of Brookline to ban fossil fuel infrastructure in new construction and building rehabs. He also successfully led a legal intervention before the Massachusetts Department of Public Utilities and stopped the utility-run Mass Save program from cutting equipment rebates for oil-fired boilers and furnaces. And in January of this year, Michael succeeded in securing the appointment of former NORA Chairman Charlie Uglietto, of Cubby Energy, to Governor Charlie Baker's Commission on Clean Heat. The Commission is charged with developing a roadmap for reducing carbon emissions in the building sector.
